#### CANCELLATION POLICY

1. All required payments must be paid in full before starting classes. Tuition refunds may be requested *before* the students' starting date. Refunds may take up to 60 days to process. Students who have begun classes but have extenuating circumstances which cause them to need to withdraw from the course may apply for a partial tuition refund at the Director's discretion.

2. If a student is denied admission or enrollment by the institution, the student will receive a full refund, except for non-refundable charges (initial application fee, I-20 processing fee, SEVIS fee, mailing fee).

3. Registration fee, I-20 Processing fee and Mailing Fee are non-refundable and non-transferable.

4. If the institution cancels the student's program of study subsequent to a student's enrollment, the institution will refund all monies paid by the student.

5. Refunds may take up to 60 calendar days to process.

6. If a student never attends class (no-show) or cancels the enrollment after their starting date, refunds may be denied.

7. If a student attends class, granted refunds will be calculated on a weekly basis after their last day of attendance.

8. Students who are enrolled with a discounted tuition of over 49% are not eligible for a refund.

9. JGL representatives have the task to submit any refund request from the student to the JGL Director. Written notification is not required, but preferred.

10. Refunds will be made only to the person, company or agency that paid the school. Students who paid for a program through an agency, must apply directly to that agency for a refund.

11. All refunds will be made in the form of a check unless the student paid by credit card, then the school will remit refund funds to the original credit card used for payment. If school related fees were paid by wire transfer, then the school will

12. A student who applies for a change of status and starts classes while waiting for the Department of Homeland Security's approval on their petition may qualify for a tuition refund in accordance to number 20.

13. A student who applies for an F1 visa, or change of status are only eligible for refunds if status is denied by the Department of Homeland Security for reasons outside of the students' control.

14. If a student would like the school to remit refund to a person other than the student, they must provide a letter authorizing JGL to make the check payable to the person assigned by the student. A valid proof of identification must be presented by assignee when claiming the check. This is only applicable to tuition payments made by cash or check.

15. If a student enters the United States on an I-20 form obtained through the school, and subsequently cancels prior to the start of scheduled classes or never attends class, the school will retain the equivalent of four weeks of payment for payments of less than 12 weeks. The rest will be refunded to the student.

16. The length of the student's enrollment period is also their Period of Financial Obligation. Students are not eligible to make up any class time lost during their Period of Financial Obligation.

17. Extended enrollment periods count as a separate, new Period of Financial Obligation and the same criteria as above applies.

18. Refunds are paid within 45 days of the student's last day of attendance/date of determination.

19. In cases where the student fails to tell the school they are ending enrollment, the date of determination is the date:

I. The school administratively withdraws the student; or

II. The school terminates the student due to failure of following the attendance, conduct or student progress policies.

20. Tuition paid on a promotional discount will be refunded at the rate paid at the time of enrollment.

21. After the start of any session the following cancellation fees will apply:

Tuition: Tuition for the full 12-week session (or to your proposed length of study, if less than 12 weeks) is nonrefundable, unless you test above our highest level of instruction or have a documented medical emergency. If you test above our highest level of instruction, tuition and fees paid will be refunded. If during your session you must return to your home country for a documented emergency, the unused portion of your tuition will be held on account for a period of one year, for use upon your return.

Accommodation Fees: The Homestay and Residence placement fees are non-refundable. If you leave your accommodation option early, a cancellation fee equal to 2 weeks of accommodation fees will apply.
